MAINTENANCE INSTRUCTIONS:

1) NEVER MAKE CHANGES OR ALTERATIONS TO YOUR PISTOL

This pistol was built to a proven and tested design, and manufactured with care. It must NEVER be altered or changed.

Changing or altering any part of your pistol may result in serious injuries to you or others, and is NOT RECOMMENDED by the manufacturer. Any changes made to the pistol or use of non-factory parts voids the factory warranty.

2) PROPER CARE AND STORAGE

Regular care and cleaning of your firearm is key to its proper functionality and reliability. ALWAYS make sure that the firearm is UNLOADED before you leave the range and check it again before you start the cleaning process.

THE RESPONSIBILITIES OF THE USER The laws of your country give you the right to possess a firearm. Appreciate and enjoy your rights with care. Be aware that, as an owner of a firearm, you are responsible for ensuring your own safety and that of your shooting partners, observers, and the environment.

IMPORTANT WARNING

- 1) Read the instructions booklet completely before using your firearm.**
- 2) Always be aware of the handling and functional characteristics of your firearms.**
- 3) Always unload your firearm when not in use (remove all cartridges).**

When stored or not in use, firearms should always be unloaded and safe. Unload and push the safety button to the WHITE position to block the trigger of your firearm.

Always remove all cartridges and inspect the chamber to ensure your firearm is unloaded.

- 1) After shooting.**
- 2) Before racking or after picking up the firearm.**
- 3) Before putting the firearm into its case.**
- 4) Any time you are not using your firearm.**
- 5) Before handing your gun to anyone else.**
- 6) ALWAYS KEEP YOUR FIREARM POINTED IN A SAFE DIRECTION.**

This ensures you do not injure yourself or anyone else.

- 7) ALWAYS STORE YOUR FIREARM OUT OF REACH OF CHILDREN OR OTHER UNAUTHORIZED PEOPLE.**

There are many ways of keeping your firearms locked and stored safely and securely. Always secure your firearm in accordance with applicable laws in your area and always unload and then lock the firearm when not in use or whenever it will be unattended.

8) ALWAYS OBEY ALL LAWS REGARDING OWNERSHIP, TRANSPORT, AND SHOOTING YOUR FIREARM. Never point your firearm at a person. Do not harm any person or damage any public property.

9) IF YOUR FIREARM DOES NOT FIRE AFTER PULLING THE TRIGGER: STOP, WAIT A MINUTE, AND USE EXTRA CAUTION WHEN OPENING THE BOLT. If your firearm did not fire after pulling the trigger STOP! Keep the firearm pointed in a safe direction, apply the safety by moving the safety button to the white position. Wait 60 seconds. Carefully open the action by pushing the lever forward and eject the shell in a safe direction. Always remember when you experience a misfire, your firearm is still loaded and could fire at any time (a "hang fire").

10) ALWAYS TREAT YOUR FIREARM AS IF IT IS LOADED, EVEN WHEN THE SAFETY IS ON. Always keep your finger away from the trigger unless you are on target and prepared to shoot. Never forget that even with safety ON, you are responsible for the direction your firearm is pointing. Do not count on a mechanical device.

11) This firearm was manufactured by Parantez R&D Defense under the control and supervision of Derya Arms. The firearm must never be altered. Manufacturer and Derya Arms do not recommend the use of any spare parts or accessories and magazines other than those included in the original box or received from Derya. If you need magazines, spare parts or repair, contact our authorized distributor in your country or Derya Arms ONLY.

12) ENSURE THE BARREL IS NOT PLUGGED OR OBSTRUCTED BEFORE YOU LOAD YOUR GUN. The barrel should not have any residue from bore cleaning solvent or oil, or any other foreign material inside the bore or chamber. If the barrel is blocked or otherwise obstructed, even partially, this may cause bulging and/or a breech explosion and/or a split barrel. If you feel a strange recoil or the report sounds unusually loud or soft STOP SHOOTING IMMEDIATELY and check the barrel for obstructions and bulges.

NEVER try to clear an obstruction in your barrel by firing another cartridge!

ANY PARTIAL OR COMPLETE BORE OBSTRUCTION can cause serious injury or death to the shooter or bystanders.

SERIAL NUMBER

The serial number is engraved on the firearm on several places. Every firearm has a unique number. This number is used for legal and warranty matters. Derya suggests that owners note and store the serial numbers of all of their firearms in a secure location away from the firearms.

CALIBER MARKINGS ARE CLEARLY INDICATED ON THE BARREL. USE ONLY THE CORRECT CALIBER ENGRAVED ON YOUR PISTOL. EACH PISTOL HAS SUCCESSFULLY PASSED DURABILITY TESTS USING SAAMI/CIP STANDARDS AMMUNITION.

WHEN STORING THE GUN FOR A PROLONGED PERIOD OF TIME, IT IS NECESSARY TO OIL METAL PARTS HEAVILY WITH AN ACID-FREE LUBRICANT. THE EXTERNAL PARTS MUST BE COATED WITH AN ANTI-RUST OIL OR GREASE TO PREVENT MOISTURE CAUSING THE PARTS TO RUST AND MALFUNCTION. BEFORE USAGE, THE PISTOL MUST BE CLEANED AND WIPED DRY AGAIN.

LOADING THE FIREARM

- 1) Insert proper cartridges into the magazine tube by pushing to the loading cap.
- 2) Push the last round with the little finger.



- 3) Pull the lever down, this action forces the firing pin and bolt backwards and a cartridge will lift up into the chamber.
- 4) Close the lever.



UNLOADING THE FIREARM

- 1) While keeping the muzzle in a safe direction, Push the lever down and forward, it will eject if there is any cartridge in the chamber. Repeat it until all the cartridges are ejected.
- 2) Once you've visually confirmed the chamber and magazine are empty, decock the hammer by pulling the trigger and slowly lowering it with your thumb.



SAFETY SYSTEM

1) This pistol features double safety system. Trigger safety locks the trigger from being pulled* when the lever is opened.

2) In order to pull the trigger, squeeze the lever with your hand. Squeezing the lever disengages the trigger safety.



3) Hammer safety blocks the hammer from hitting the firing pin*, in order to disengage the hammer safety, push the button as shown, to apply safety again, push the button from other side of the receiver

2) Once you apply the safety, you can decock the hammer by pulling the trigger while holding the hammer with your thumb and releasing it slowly.



YOU SHOULD NEVER DEPEND ON A SAFETY MECHANISM OR ANY OTHER MECHANICAL DEVICE TO JUSTIFY CARELESS AND IMPROPER HANDLING.



IMPORTANT WARNING

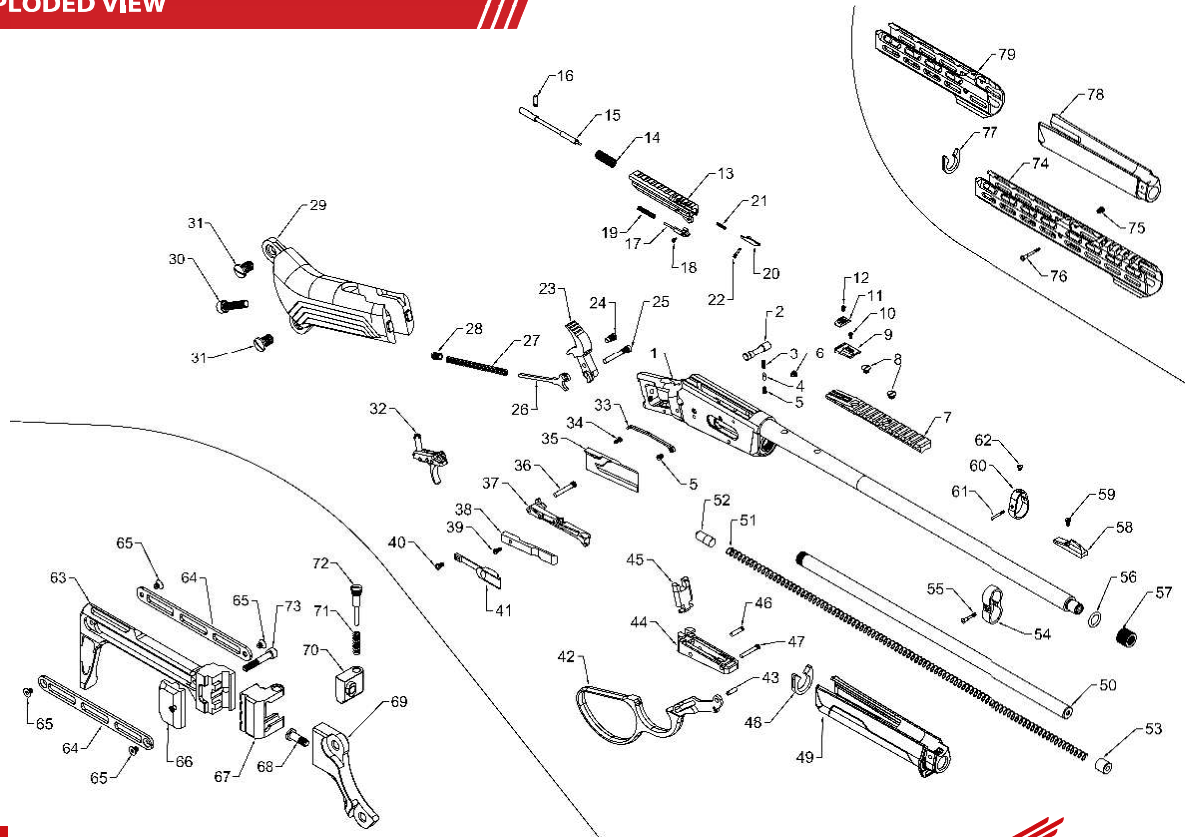
The STEEFANG PSB / Ironwolf grip is designed solely to aid in one-handed firing by stabilizing the pistol against the shooter's forearm. **It is NOT a shoulder stock.**

Always follow all federal, state, and local laws regarding firearm classification, possession, and use. Derya Arms classifies the RANX as a pistol. Any modification or misuse of the brace voids the warranty and may be illegal. Store and use the firearm in accordance with all safety instructions in this manual.

Never place the brace against your shoulder or use it in a manner that would cause the firearm to be fired from the shoulder.

Doing so may reclassify this pistol as a short-barreled rifle (SBR) under federal law (National Firearms Act) and applicable state laws, subjecting the owner to severe penalties.

LIMITED LIFETIME WARRANTY

South Derya Corporation dba Derya warrants that the enclosed firearm was originally manufactured free of defects in material, workmanship and mechanical function. For the lifetime of the original owner, Derya agrees to correct at its own expense any defect in a Derya Firearm for the original purchaser by means of adjustment, repair or replacement, as appropriate in Derya's sole discretion.

What and who is covered by this limited warranty?

This Limited Lifetime Warranty issued by South Derya Corporation dba Derya covers defects in material and workmanship for the original purchaser. This warranty is non-transferable and applies only to the original purchaser. The warranty includes repair, adjustment, or replacement of the firearm, at the manufacturer's discretion, with the same or comparable quality components, or replacement of the firearm itself.

What is not covered by this limited warranty?

This warranty is void if the firearm is: Misused, damaged accidentally or otherwise, or fired with hand-loaded, reloaded, or improper ammunition, Fired with an obstruction in the barrel or damaged due to failure to follow maintenance instructions provided in the manual, Altered or repaired by unauthorized personnel, including any cosmetic modifications, accessory items attached to the firearm are not covered, Damage to decorative finishes or any aftermarket modifications is not covered, and normal wear and tear is not included under this warranty.

What to do for warranty service?

To initiate a warranty claim, obtain a Return Merchandise Authorization (RMA) by contacting customer service by phone at 904-420-2923 or by visiting www.derya.us. Return the unloaded firearm, freight prepaid, to the address provided by customer service. Derya will provide free of charge a repaired, reconditioned, or new firearm (at Derya discretion).

This Limited Warranty supersedes any and all express warranties.
